### Letter from the Chair

Many factors influence a child's response to domestic violence. Some children may show obvious signs of stress or emotional distress. Others could be more isolated, quiet and withdrawn. Those same factors for children that experience domestic violence vary: such as age, trauma history, and severity of the violence they witness.

Educational and therapeutic programs like Randi's Kidz Club have proven to be a great model to address the needs of children who witness domestic violence. Since 2012 Randi's Kidz Club has helped over 40 children. The children meet weekly with therapists and learn about safety planning and conflict resolution. Children find a safe place to talk about their experiences and learn that they are not at fault for what they experience.

Randi's House of Angels is continuing to grow as we assess the needs of children who experience domestic violence. In the next few months we will be launching Randi's Clubhouse, a new program for children ages 5-7. This new program will blend emotional and art therapy, and psycho education to children using kind, gentle and playful interactions. The program will involve non-violent parents or caretakers.

My dream is to continue to stop the perpetuation of domestic violence by stepping in early and putting our children first.

Children who witness domestic violence or are victims of abuse themselves are at SERIOUS RISK FOR LONG-TERM PHYSICAL AND MENTAL HEALTH PROBLEMS.

### Randi's Race 2018: A 5K Run/Walk For Hope and Courage

Last May, we completed our 14<sup>th</sup> annual Randi's Race. Raising more than \$35,000 this year, our grand total has now topped \$423,000 over the course of this community 5K event. At this year's race, 13 energetic teams raised \$6,035.

These important funds allow RHOA to operate and grow the programs we offer to area children. Earlier this year, we announced Randi's Camp and Randi's Kidz Club now serves children in 6 counties: Cumberland, Perry, Dauphin, York, Adams and Lebanon. Randi's Race funds also help support programs and services for children at Domestic Violence Intervention of Lebanon County. This year marks the 15<sup>th</sup> anniversary of Randi's death.

Our many volunteers, community partners, sponsors, vendors and local township/EMS workers continue to work together, organizing our event to run smoothly and safely. Additionally, our partners have an opportunity to showcase their important services to the community at Randi's Race. # MAKING A DIFFERENCE – A Mother's Story

For me to be writing in this newsletter is surreal. I swore that my children would never experience domestic violence as I did when I was a child. While there was no Randi's House of Angels back then, I did get help from a program in my hometown in New Jersey. My sister, however, refused. Furthermore, she was angry with me for letting people know what was going on. I got help as a child, and she didn't. I am here writing this article, and she watches over us from Heaven after having been murdered by her husband.

Even after it was pretty clear that our children did experience domestic violence, I tried to shrug it off, like it never happened. After all, so many people I spoke to said things like "kids are resilient," or "they were so young, they probably won't remember anything." Thanks to a conversation with Nancy Chavez, I realized that the children did experience domestic violence and they deserve help just like any adult does.

My eldest child, actually my sister's eldest, attended both Randi's Kidz Club in the winter and Camp in the summer, and the experience has



been amazing. Prior to attending Randi's Kidz Club, she was so hesitant to show me affection. One of the nights when I was waiting for her to be done with the session at the Kidz Club, she literally ran up to me with open arms and hugged me. I was floored. Prior to the club, that had never occurred. Now hugs are a constant occurrence. In the winter she started out asking for a hug, and since attending camp this past summer, she even hugs both my husband and me without asking first. I know that as an outsider looking in, as someone who never had to deal with domestic violence, this probably sounds pretty trivial, but the truth is that it is huge. She is finally at a point where she feels safe. Furthermore, she is excited to go back to the club and camp. She can't wait to go back, share more, and learn more. I too am excited that this little girl will grow up to know what a healthy relationship looks like and be able to walk away from one that is not good; I am excited that she will have the tools to end the cycle of domestic violence in our family.

I first met and subsequently became friends with Nancy in 1993 during my initial semester at Penn State Harrisburg's evening graduate program. Through Nancy, I was blessed to have also met her daughter Randi and admired the very close mother/daughter relationship that the two of them shared. When I was asked to serve on the RHOA Board, the decision was a very easy one.

While I had no former knowledge or experience with domestic violence unlike many of the other individuals who served on the board, I knew that I had some skills to bring to the table, having worked in nonprofit management all of my professional career. More

important than any of that though was the emotional connection I had to the mission of the organization as a result of Randi's tragic death. I remember thinking that awareness is key and that it would be very fulfilling to be a part of an organization that made people aware of domestic violence BEFORE a tragedy occurs. The commitment that the organization and in particular, Nancy Chavez has to providing services to children is uplifting and serving on the board of directors is one of the best decisions I have made. I feel many emotions about serving, but more than anything, I feel lucky.

My 20-year old daughter Emily has also become involved in various aspects of RHOA, and I am extremely proud of her commitment and service. As a mom, I am also hopeful that her exposure to and her awareness of this often-hidden epidemic will prevent her from ever becoming a victim.
