Letter From The Chair

He was committed to serving in a leadership role on Randi's House of Angel's board, volunteered at Randi's Camp to serve as a role model for young boys and girls, and attended events supporting domestic violence.

More importantly, Greg was one of many men that shared his thoughts on the importance of how we need to change male attitudes towards physical, mental, and psychological abuse toward women and girls. Perhaps if we had more Greg Greens in our community who look at the "male macho" mentality as being detrimental to our communities, perhaps we would not be talking about this. More men talking about domestic violence will help young boys old enough to enter into serious relationships of their own.

Sadly, we lost Greg in December, but he will be forever in our hearts, as we continue to thank him for his leadership in moving this cause forward.

2020 RANDI'S VIRTUAL RACE: ANNUAL 5K RUN/WALK FOR HOPE AND COURAGE

As you may know, there is a lot of uncertainty about the spread of COVID-19 virus and the future of our communities. We have made a difficult and yet the right decision to transition Randi's Race: A 5k Run/Walk for Hope and Courage to a Virtual Race. We remain hopeful that the threat of COVID-19 will soon diminish and that we can responsibly return to our normal activities. However, public health and safety remain a top priority, and we plan to continue to follow the directives of national and local health authorities.

WHAT'S A 'VIRTUAL RACE'? A virtual race is a race you can run or walk from the location of your choice. You can run, jog, or walk on the road, on a trail, on a treadmill, or on the track. You get to run your own race, at your own pace, and time it yourself! After the virtual race, participants can post their times and be recognized on our race results page.

2019 GOODWILL AMBASSADOR

The 2019 Goodwill Ambassador Award was presented to Randi's House of Angel's President, Nancy Chavez, during the 2019 Conference for Women sponsored by Eye Candy. This annual award is given to a woman who is focused on community outreach, business and personal philanthropy efforts and who demonstrates leadership characteristics in our community with proven results.

When asked for a recommendation for this award, one fellow community leader wrote: "It has never been about her or her organization but what could she do to counter the damage done by domestic abuse. With her determination, credibility, intelligence, and ability to network, Nancy built an army of advocates who share the vision that children should be nurtured, protected, and healed from the trauma they experienced through no fault of their own." Nancy was selected from over 20 nominees and 10 finalists from the Central Pennsylvania region.

NEVER GIVE UP!A Mother's Story

No one wants to be a statistic. Even so, as a young family, I, my husband and our two children, Cora, age 8, and Malcolm, age 4, became 2 of the 15 million children in the U.S. who witness partner violence in the home at least once over a three-year period. As an educator I knew the negative effects of witnessing domestic violence in the household increased my children's chances of using abusive behaviors, and as a mother I knew I needed support to help end the vicious circle of domestic violence in my family.

Randi's House of Angels and Randi's Camp was the answer to my prayers and the support and continuing education my children required. Through participating in Randi's Camp for five consecutive summers, my daughter Cora, now age 18, went from a shy, traumatized child to an outgoing empowered young lady. In fact, she spoke to a crowd of over 100 people during Randi's Race about her experiences at Randi's Camp; she said the camp made her feel safe and at home because she was able to share her concerns with other kids who had experienced domestic violence. My son Malcolm, now 13, has been a camper at Randi's Camp since age 6. He looks forward to the fun group activities, the yummy food, and catching up with the other campers.

The bond formed between my children and the highly qualified counselors who volunteer their time is incredible. I am grateful to know such intelligent kind-hearted people. They have empowered my family to beat the odds and not become another statistic. While overcoming domestic violence is a long journey that many choose not to make due to ignorance and lack of support, Randi's House of Angel's is a topnotch non-profit organization that will be there for you and your family in the long run. Board of Directors: Spotlight on Julie Barley

My ties to Randi's House of Angels began on a personal level many years ago. Randi, who my husband, Terry, and I knew briefly was a beautiful person. She was caring of others, and it was clear she had a bright future as a speech therapist. To this day I cannot imagine the emotional impact her tragic death had on Nancy, her mother. The ability to not only deal with such a loss but to go forward and build an organization dedicated to helping children demonstrates Nancy's strength and resolve. We kept in contact with Nancy through Randi's Race and other events where Nancy spoke and shared her and Randi's story. Often Randi's House of Angels was mentioned and later became a reality.

Fourteen years ago Nancy, as chair of the Cumberland County Commission for Women, recruited me to serve. As a member of the Commission's Committee Against Violence to Women I learned about domestic violence in our community through mock trials and other events. My compassion for persons living in situations of domestic violence grew. Because of a professional

background in mental health and children's services, I understood the devastating impact of trauma on the individual. However, I saw a more personal role that I could have in helping others locally.

In 2015 I was honored to be asked to serve on Randi's House of Angels board. What really brought me to the board was a desire to help develop treatment and intervention programs for children exposed to domestic violence. For that reason I have served on the Program Committee. In the last year, Randi's Kidz Club has expanded its locations, and a Randi's Klubhouse, which includes parents and younger children, was implemented. The summer therapeutic/recreational camp continues annually. Currently the Program Committee is planning an educational forum on the impact of trauma. A truly dedicated group keeps our services to children moving forward.

Across the board Randi's House of Angels has an amazing array of talented persons. Much work has gone into the expansion of fundraising, marketing and public relations. And the glue that keeps that and all of us together is Nancy.
